#### **INFRASTRUCTURE PERMITTING**

As the wets get wetter and dries get drier, we must identify opportunities to streamline the regulatory permitting process so that critical infrastructure projects are built at the pace and scale needed to prepare for climate change. This panel will discuss ACWA's sponsored bill, SB 23 (Caballero), which intends to expedite the permitting process for water supply and flood risk reduction projects.

## INFRASTRUCTURE FUNDING

This not only includes creating more above and below-ground storage, but also diversifying water supplies through desalination and recycling, as well as improving flood protection and dam safety. 
