1. Eastern San Joaquin Groundwater Authority Ad-Hoc Technical Advisory Committee (TAC) Meeting, 01/07/21

Director Watkins and Manager Moody attended the January 7, 2021 Eastern San Joaquin Groundwater Authority Ad-Hoc Technical Advisory Committee (TAC) Meeting. Manager Moody reported the recap of the last several months was given and discussion focused on Department of Water Resources (DWR) response on the Groundwater Sustainable Plan (GSP) that was submitted.

Manager Moody reported North San Joaquin Water Conservation District's monitoring well has been completed and the Committee inquired on the status of SEWD's monitoring well. Manager Moody reported DWR wanted to start drilling tomorrow but the District is waiting on the County to approve the Permit. Manager Moody added staff will follow-up with the County on the status this afternoon. Director McGaughey inquired on the Committee's Agenda Item: 3b – Threats. Manager Moody replied the Committee is waiting on DWR's review and comments on the GSP, and the possibility on DWR commenting on groundwater pumping curtailment not be included in the GSP. The next scheduled meeting is to be determined.

F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 01/04/21

Manager Moody provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

There is 132,613 AF in storage at New Hogan Reservoir. Current releases are set at 28 cfs. There is 1,551,931 AF in storage at New Melones Reservoir. Current release at Goodwin Dam to Stanislaus River are set at 202 cfs and release to all water users are set at 37 cfs. The water treatment plant is currently processing 17 mgd. The City of Stockton is offline and is supplying 12 MGD via wells.

Re:	Peters Pipeline 66-inch Vault Outlet Automation and Flow Measurement

BACKGROUND

As part of the 2021-2022 budget, the Board authorized \$100,000 for the design and construction of an automated flow measurement project at the Peters Pipeline 66-inch Vault Outlet structure (Figure 1), upstream of the Mormon Slough railroad bridge crossing. There is an existing 66-inch manually operated slide gate and a short section of 66-inch reinforced concrete pipe (RCP) discharge pipe. This project is especially important as the District proceeds with the Hosie crossing and other projects. The automated diversion will allow staff to supplement the irrigation flow rate in the Mormon Slough with New Melones water and provide for remote capability to discharge water not suitable for treatment or during an emergency. The project also decreases upstream diversion requirements into Mormon Slough, thereby decreasing flows to be bypassed through upstream construction sites.

SUMMARY

The proposed solution for automation of the 66-inch vault outlet is to install a new, accurately measured, and autonomously controlled diversion point. The ability to accurately measure flow and automate the flow rate released to the Mormon Slough from the Peters Pipeline will <u>decrease</u> daily visits to the 66-inch Vault Outlet structure for gate adjustments while simultaneously improve delivery reliability. The project will replace the existing manual slide gate inside the control vault with a Rubicon SlipMeter. The SlipMeter is similar to the automated gate recently installed at the Mosher Creek Headworks and from the same manufacturer of automated gates installed at PC-1, PC-2, and the Lower Farmington Canal Headworks. The SlipMeter can be remotely operated and will automatically deliver a constant and accurately measured flow rate and volume. This means the District can provide consistent service day or night, even when water levels are fluctuating.

PROJECT COST

Staff considered installing utility power to the site, an actuator on the existing slide gate, and an in-pipe flow meter. The option to electrically actuate the existing gate and install a new flow meter would be over \$50,000, not including costs for utility power. The cost of the proposed SlipMeter is \$41,000 (plus tax), which provides a \$9,000+ cost savings. The total estimated proposed project cost for the SlipMeter option is \$88,500, including the following items:

NEXT STEPS

District staff plan to construct the project after April 1, but before irrigation season, to benefit from supplemental flow diversions into Mormon Slough downstream of the Hosie Crossing project. Because the gate's approximate 12 week lead time, staff requests to purchase the gate now for delivery around the beginning of FY21-22. Payment for the gate will be made after receipt and within the FY21-22 budget.

If the Board has no objection, the General Manager will authorize staff to purchase the SlipMeter for \$41,000. The total estimated project cost is within the FY21-22 project budget of \$100,000.
