

Manager Hopkins reported this agreement will allow the District to bill for the water diverted from Pixley Slough as part of the exchange agreement with North San Joaquin Water Conservation District.

Director Cortopassi inquired how the District would ensure water delivery to the Elkhorn Golf Course. Manager Hopkins clarified North San Joaquin Water Conservation District would ensure water would be delivered. Director Watkins added Woodbridge's canal tailwater would also supply water.

Manager Hopkins reported AB1637: Local government: internet websites and e-mail addresses was introduced in the State of California's Legislature. The bill would have required local agencies that do not use a domain name that ends with .gov or .ca.gov to change their current domain name to end with either of those governmentally-related suffixes. In anticipation of possible passage of AB1637, District staff began investigating the necessary steps to register either sewd.gov or sewd.ca.gov. The District's IT provider, Verve Networks, Inc. was engaged to help our efforts and they were able to point out resources for staff to investigate. Staff determined the cost of registration was free for both the .ca.gov suffix and the .gov suffix. Manager Hopkins added the next step would be to submit a letter, found on page 20 as Exhibit A.

Director Sanguinetti inquired what the cost would be to update the web address on various things like letterhead or business cards. Manager Hopkins clarified there would be no cost as we are only reserving the domain and not putting it into use.

### F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 06/06/23

Manager Hopkins provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

There is 235,308 AF in storage at New Hogan Reservoir. Current releases are set at 227 cfs. There is 1,938,632 AF in storage at New Melones Reservoir. Current releases are set at 2,462 cfs. Current release at Goodwin Dam to Stanislaus River are set at 1,505 cfs and release to all water users are set at 2,734 cfs. There are 13 irrigators on New Hogan, 4 irrigators on New Melones, and 4 irrigators out of District. The water treatment plant is currently processing 34 mgd. The City of Stockton is currently processing 25 mgd.

Director McGurk inquired if the total cfs diverted to SEWD and CSJWCD under Farmington Dam (FRM) should equate to 240 cfs. Manager Hopkins clarified normally the total would add up to slightly less however, staff recently noticed water was pooling behind the Farmington Dam due to the gates not being opened fully. Farmington Dam has since opened their gates another foot and the flow should return to normal.

Manager Hopkins noted item: F2a-1, F2a-2, F2a-3 and F2a-4.

### 3. Report on General Manager Activities

a. Stockton East Water District Activities Update

Manager Hopkins reported he, Legal Counsel Zolezzi and the District's water rights consultant participated in an informational meeting with the State Water Board regarding the implementation of SB88. The State Water Board would like to schedule a follow-up meeting in person to discuss SB88 in more detail. Legal Counsel Zolezzi added we are working with the State Water Board to see what can be done to ensure the District is compliant with SB88.

Manager Hopkins reported he received some information for the Parjana product however, the product is costly. As an alternative, staff will be working on a pilot project to increase groundwater recharge efficiency by constructing an infiltration trench in the overflow reservoir that breaches the hardpan layer, which is about five feet below grade. President Atkins inquired how deep would staff drill down for a dry well. District Engineer replied, typically 20-100ft. President Atkins inquired if we have considered installing a dry well. Manager Hopkins replied District Engineer Evensen has investigated that option with the cost being around \$80,000 compared to the cost of the infiltration trench being around \$15,000.

Manager Hopkins reported the Department of Water Resources provided the Groundwater Authority with the scoring results with the SGMA Round 2 Grant. The Eastern San Joaquin Groundwater Authority application scored 24 out of 28 however, was not rewarded the grant for \$20M. There were three projects within the application which did not score as well due to not having benefited enough disadvantaged areas.

### G. DIRECTOR REPORTS

1. Regional Water Authority Meeting with Jay Ziegler, 06/07/23

Director McGurk and Director Panizza attended the Regional Water Authority Meeting with Jay Ziegler. Director McGurk reported Ziegler was very knowledgeable and his experience applies to his current role as Delta Watermaster. Director Panizza reported Ziegler discussed conflicts with

his current role as Delta Watermaster. Director Panizza reported Ziegler discussed conflicts with projects from federal and state regulations, water storage and various mandates and how he can develop methods to address these conflicting demands.

2. Stockton East Water District – 75<sup>th</sup> Anniversary Celebration, 06/09/23

President Atkins reported the event turned out great, ran smoothly, and staff did a professional job preparing for the event.

Director Sanguinetti added the tours were successful and received positive feedback from many attendees. Director Sanguinetti further commented the display booths were informative and suggested the District should extend gratitude to those vendors who set up booths.

Director Panizza added staff organized the event very well.

Director McGurk added the councilmembers' and senator's presence was a compliment to the District.

Director Cortopassi commended the committee and staff for putting together the event.

Manager Hopkins reported around 200 people attended the event and added the District received many certificates of recognition which are now displayed in the lobby of the Administration building. Manager Hopkins gave special thanks to Finance Director Ram for her efforts in preparing for the event as well as her work the day of. Manager Hopkins noted the silent auction and raffle items generated \$2,365.

Re: Consider Withdrawal of Protest to Water Right Application A033342

### **Background**

On March 9, 2023, the Stockton East Water District (District) received a Notice of Water Right Application A033342 from the State Water Resources Control Board (SWRCB). The application proposed to divert up to 42 acre-feet of water per year from the New Hogan Reservoir watershed for incidental stock watering and recreational use within a four acre pond. On April 11, 2023, the Board of Directors (Board) agreed to protest the application due to the potential impacts on the District's water supply and the quality thereof. On April 14, 2023, the District's legal counsel submitted a formal protest to the SWRCB citing the District's concerns.

### **Summary**

On May 19, 2023, the SWRCB accepted the District's protest and directed the applicant, Whiskey Slide Ranch Family LLP, to discuss potential resolution with the District. The applicant met with the District's legal counsel and advised Whiskey Slide Ranch Family LLP is a new owner of the property and attempting to properly permit diversions to a recreational reservoir that have historically occurred. The applicant stated the diverted water is solely for recreational use and used to refill the estimated eight acre-feet of annual evaporation from the ponds. The applicant requested the District withdraw its protest.

The issuance of a permit will only divert eight acre-feet from entering the New Hogan Reservoir, but will contribute to the cumulative depletion of upstream runoff. A condition of the permit could include the provision that water may only be diverted when New Hogan Reservoir is in flood stage, during which time water would be released from the reservoir anyways. The proposed condition was conveyed to the applicant, however the applicant has not responded nor indicated any willingness to accept the proposed condition.

### **Financial Impact**

There is no financial impact.

### Recommendation

Staff recommends Board withdraw the District's protest in exchange for the amendment of Water Right Application A033342 to only allow diversion under the permit to occur when New Hogan Reservoir is in flood stage.

Re: Low Lift Pump Station P1 Pump Replacement Check Valve

#### **Background**

The Stockton East Water District's (District) Fiscal Year (FY) 23-24 approved budget includes funding for the replacement of the Low Lift Pump Station's (LLPS) P-1 Pump. On May 23, 2023 the Board approved purchase of a new 250 HP pump to replace P-1. In order to make the new, higher horsepower pump operational, other accessories need to be purchased. These accessories include valves and electrical system components.

#### **Summary**

District staff obtained quotes to purchase a center-post guided "silent" check valve for the 250 HP P-1 pump to match the installed check valves on all of the pumps in the LLPS. The check valve ensures that water is not able to flow backwards through the pump while not in service and is designed to reduce transient pressure waves associated with water hammer. **Table 1** below lists the quotes received from the two center-post guided check valve vendors for the 30-inch check valve. The lower-cost check valve is the same manufacturer of the existing check valves at the LLPS.

#### **Financial Impact**

The approved budget for this project is \$380,000 and \$255,866 have been spent so far for the pump and other materials. After the purchase of the check valve, approximately \$68,597 will remain based on the conservative assumption of the contingencies being fully used.

#### Recommendation

Staff recommends the Board authorize the General Manager to approve the purchase of a 30-inch Val-Matic check valve from B&K Valves & Equipment in the amount of \$55,537 plus a 10% contingency of \$5,554 for a total amount of \$61,091, and make all other necessary approvals.

The State Water Resources Control Board (State Water Board) is writing to inform you of a recent incident that may impact the privacy of some of your information. While we are not aware of any access to or use of this information, we are providing this notification letter as a precaution to inform you of the incident and our response.

#### What Happened?

On May 25, 2023, the State Water Board discovered an unauthorized disclosure of information which occurred on September 16, 2022. The disclosed information was contained in a document provided in response to litigation involving the 2021 and 2022 drought emergency regulations for the Sacramento-San Joaquin Delta watershed. A document containing information for water right holders in this watershed was shared with attorneys representing parties in the case. Within that document was information that could be used by a knowledgeable person to access your information in, or submit reports to, account(s) in the Electronic Water Rights Information Management System's Report Management System (RMS), and the Water Right Form and Survey Submittal Portal (Survey Portal). Please note, the State Water Board has no indication of inappropriate access to or use of water right holder accounts.
