

President Watkins called the regular meeting to order at 12:30 p.m. and Director Panizza led the Pledge of Allegiance.

Present at roll call at the District were Directors McGurk, Sanguinetti and Watkins. Also present were Manager Moody, Assistant Manager Hopkins, Finance Director Vega, Administrative Services Manager Carido, Administrative Clerk Feliciano and Consultant Barkett. Present at roll call via teleconference were Directors McGaughey and Panizza. Directors Atkins and Cortopassi were absent. Also present via teleconference was Legal Counsel Zolezzi.

3. Stockton East Water District – Injury & Illness Prevention Plan Update Manager Moody provided the Board with an Injury & Illness Prevention Plan (IIPP) Update. Manager Moody reported this Plan should be reviewed by the Board annually. Manager Moody reported ACWA/JPIA provided the District with a new Supervisor's Accident/Incident Investigation Form that is a required document for the Board Policy and is the only update to the IIPP.

E. COMMITTEE REPORTS

1. Eastern San Joaquin Groundwater Authority Steering Committee Meeting, 10/13/21 President Watkins and Manager Moody attended the October 13, 2021 Eastern San Joaquin Groundwater Authority Steering Committee Meeting. Manager Moody reported the Committee began with a Resolution for Assembly Bill 361 Open Meetings: State and Local Agencies: Teleconferences. Manager Moody reported a brief presentation on the basin accounting framework which discussed various consultants that will be hired to help with the process of allocating responsibility of the basin. Manager Moody reported he inquired about water quality as there are a total of seven undesirable results that are required to be address if problematic in the basin, however water quantity is the only concern that has been discussed by the Committee. Manager Moody added the State Water Resources Control Board (SWRCB) wrote a letter to Department of Water Resources about certain Groundwater Sustainability Plans (GSPs), like us, that are not addressing all concerns within their groundwater basin. Manager Moody commented he was taken back by San Joaquin County's forceful reply that water quantity is the only concern that will be addressed unless the implementation projects that are being completed cause concern, then they will be addressed at that time. Manager Moody reported the County discussed the letter from the SWRCB to Department of Water Resources as being an over reach but the SWRCB is tasked with implementing the SGMA Law and enforcing it which means our GSP should pay attention to

F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 10/11/21

Manager Moody provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

the comments made in that letter. The next meeting is scheduled for November 10, 2021.

There is 86,926 AF in storage at New Hogan Reservoir. Current releases are set at 68 cfs. Current release at Goodwin Dam to Stanislaus River are set at 623 cfs and release to all water users are set at 0 cfs. There is 0 irrigator on New Hogan and no irrigator(s) on New Melones. There are currently no Out-of-District irrigator(s). The water treatment plant is currently processing 21 mgd. The City of Stockton is currently processing 20 mgd.

2. Information Items:

Manager Moody noted items: F2a-1, F2a-2 and F2a-3.

3. Report on General Manager Activities

a. Central Valley Project Water Association – Executive & Financial Affairs Committee, 10/15/21

Finance Director Vega attended the October 15, 2021 Central Valley Project Water Association – Executive & Financial Affairs Committee Meeting. Finance Director Vega reported discussion from Richard Welsh who oversees the large projects which include

Folsom Safety Dams, BF Sisk and various potential WIIN Act projects. The projects were discussed in order to inform the Central Valley Project (CVP) contractors of the possible obligations that would be passed onto them once the projects are completed; for instance, for the Folsom Safety Dams the cost would be split CVP wide at 15% of the project cost which would be implemented in 2023 or 2024. Finance Director Vega reported the other various project costs paid by CVP contractors would be determined by a matrix that defines where the benefits for each project will occur and if those benefits are reimbursable based on CVP and Bureau of Reclamation laws; the outcome is presently unknown as the benefits have not been defined yet. Finance Director Vega reported the committee wants the Bureau of Reclamation to create a chart that lists pertinent information that would inform contractors of their possible obligations; the committee will follow-up with the Bureau of Reclamation to acquire the chart from them. Finance Director Vega reported the Bureau of Reclamation quietly sent out a draft reclamation manual edit to its extended repayment procedures for Extraordinary O&M projects which are usually large. Said projects are usually paid in the subsequent year after completion. Finance Director Vega explained the extended repayment period means the contractor can enter into a contract with the Bureau of Reclamation to extend the repayment. Concern was expressed that the manual has been updated and the comment period is only about a week; the draft extended repayment manual was not sent out for engagement so contractors discussed asking for an extension to the draft and an outline of the changes made to the manual. Manager Moody commented Legal Counsel Zolezzi needs to be informed of the information regarding the Bureau of Reclamation. Finance Director Vega replied he will send Legal Counsel Zolezzi the email regarding the issue. Manager Moody directed a comment to Legal Counsel Zolezzi to inform her that Finance Director Vega has been directed to speak to the Executive & Financial Committee about the Bureau of Reclamation's proposed water transfer about being transparent and defining the process that they used for East Side contractors' allocations on a yearly basis. The next meeting is scheduled for November 19, 2021.

b. Stockton Area Water Suppliers (SAWS) Meeting, 10/15/21

Manager Moody attended the October 15, 2021 Stockton Area Water Suppliers (SAWS) Meeting. Manager Moody reported discussion about the drought and issuing a message about water conservation; the conservation coordinators for each entity spent time sharing ideas for water conservation. Manager Moody reported San Joaquin County is considering the idea of encouraging conservation as a way of life, however, the District does not have a storage contract with New Melones and a conservation message would mean that water conserved would be available for use but that is not true; the language published for water conservation will have to be shared correctly. Manager Moody reported discussion about the status of the New Hogan Reservoir now and in the future; the District not only provides water for Municipal & Industrial (M&I) customers but also to Agricultural customers. Manager Moody explained whatever water M&I customers do not use, the Agricultural customers will use and unless there is enough rain this year, we will probably drain the reservoir. Manager Moody added we do not hold onto water for the following year for our M&I customers. Manager Moody reported discussion on the Bureau of Reclamation water transfer that the District is opposing and Legal Counsel Zolezzi reported the Bureau of Reclamation will not be executing the water transfer this year.

c. Stockton East Water District Activities Update

Manager Moody reported the City of Stockton has flushed their inter connection with the District to the north part of the city; the City of Stockton will take their last residual sample

tomorrow and once the sample has an acceptable chlorine residual level, they will begin taking water from the District to the north side of the city.

Director McGurk inquired if the Bureau of Reclamation water transfer goes to the Westlands. Manager Moody replied yes in that direction, included as well are other small municipal agencies for health and safety; Westlands was the water transfer that the District was opposing. Director McGurk inquired why the Bureau of Reclamation will no longer be doing it this year. Manager Moody replied the water transfer will not be executed this year. Legal Counsel Zolezzi added the reason was because of the exchange, there were two parts to the transfer; Westlands had purchased water from CVP contractors in Folsom and it was to be released from Folsom but they wanted to keep the water there so they were going to release the water from New Melones to exchange for the transfer to Westlands, and secondly, to get additional water to M&I. Legal Counsel Zolezzi reported the California State Water Resources Control Board approved the Westlands exchange and denied the additional transfer for M&I uses but the Bureau of Reclamation could no longer transfer the water due to the consultation period being over. Director McGurk inquired about the high release reported on F-1, Water Supply Report. Legal Counsel Zolezzi replied the release is for fall pulse fish flows. Director McGurk inquired if the water is abandoned once it reaches the Delta. Legal Counsel Zolezzi replied normally yes, however they are not using that water for the exchange with Wetlands because they have released the transfer water from Folsom.

South Percolation Pond Maintenance and Efficiency

BACKGROUND

The District installed the North and South Percolation Ponds in 2003 as part of the Farmington Groundwater Storage Pilot Project to provide recharge in the underlying aquifer. After one year, the District's "Farmington Project – Groundwater Storage Pilot Phase Report" documented that the anticipated average percolation rate based on a percolation test was 3.6 inches per day, but the actual percolation rate was 6.6 inches per day.

The design of the North and South Percolation Ponds followed a patented design utilized for several Central Valley designs (mainly Leaky Acres in Fresno) with a ridge and furrow layout. The idea at the time was to create ridges and continually raise and lower the water level so that any sediment would roll down the ridges and settle in the furrow area, thereby allowing more time for higher percolation rates along the ridges. After several years, the ponds would have to be cleaned out and the furrows recreated. It turned out to be a costly operation and maintenance item. This patented design is no longer followed at Leaky Acres or other facilities.

<u>SUMM</u>ARY

The District Staff recently removed the islands and deep-ripped the South Percolation Pond. After the rehabilitation work was complete and the pond recharged, staff measured the South Percolation Pond water level elevation hourly on October 13, 2021 from 9 AM to 4 PM. Over the 7-hour period, the water level had decreased 0.15 feet, which translates to a percolation rate of 6.24 inches per day, after accounting for evaporation losses. This value correlates with the result that was previously obtained in 2004 of 6.6 inches per day.

RECOMMENDATIONS

Staff recommends that each percolation pond be dried sometime between the Summer to Fall to scrap off the top layer of soil/sediment. Each percolation pond should also be deep-ripped every five years. This will reduce any potential clogging that can occur which reduces the percolation rate and aquifer recharge.

Re: Structural Review of Sedimentation Basins 1 & 2

BACKGROUND

In 2007, the District increased the maximum Water Treatment Plant flow capacity by 45 MGD by constructing Sedimentation Basins 3 & 4 with plate settlers, bringing the total available treatment capacity to 65 MGD. The roughly 44-year old Sedimentation Basins 1 & 2 were designed for 20 MGD. Equipment related to Sedimentation Basins 1 & 2 is reaching the end of its useful life, requiring evaluation of the basins before staff can perform value engineering for the rehabilitation of the existing facilities or full replacement.

SUMMARY

After 44 years of operation, Staff requests that the District contract with a Structural Engineer, a specialized subset of civil engineering, knowledgeable in water bearing treatment structures to analyze the condition of Sedimentation Basins 1 & 2. The analysis will determine if the concrete integrity can be maintained for another 50 years, and if so, what it would take to either rehabilitate the existing facility or update it for plate settlers to give Operations Staff more flexibility in meeting the needs of our customers.

With either the rebuild or upgrade options, replacement of the motor control center MCC-2M (\$302,900) is required. The upgrade to plate settlers option is estimated at \$2,950,000 and the rehabilitation options is estimated at \$400,000; including:

- Traveling bridge PLC improvements (\$100,000)
- Traveling bridge painting (est. \$50,000)
- Launder replacement (est. \$250,000).

Staff received quotes from three structural engineers for these services and found that Keller Associates provided the best overall cost.

RECOMMENDATIONS

Staff recommends that the Board authorize the General Manager to contract with Keller Associates to assess the condition of the basins and identify recommended improvements to the basins to facilitate the installation of plate settlers. The fiscal year budget has \$25,000 available in Professional Services Planning to hire a structural engineer. Keller Associates quoted these services at \$24,710.




