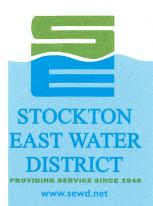

E. COMMITTEE REPORTS

1. Eastern San Joaquin Groundwater Authority Ad-Hoc Technical Advisory Committee (TAC) Meeting, 01/06/22

Director Watkins and Manager Moody attended the January 6, 2022 Eastern San Joaquin Groundwater Authority Ad-Hoc Technical Advisory Committee (TAC) Meeting. Manager Moody reported an update was given on calibrating the model and noted the overdraft figure for the basin-wide deficit is ~21,000 acrefeet per the model. President Watkins reported the groundwater model is done and the Consultant from Woodward and Curran and the GSAs can do a lot of the accountability. President Watkins reported a lot of the recharge and water is common pool and David's Engineering was hired to look into the GSAs and determine who is responsible and reported there will be upcoming meeting to determine who is responsible. President Watkins commented in the end the GSAs are dividing up 21,000 acre-feet and maybe instead of determining who is responsible, all should pitch in to fix it, particularly Districts who have water and can help out other GSAs. Consultant Barkett inquired if they broke-down the 21,000 acre-feet. President Watkins replied no, that is why David's Engineering was hired.

President Watkins reported official comments from Department of Water Resources (DWR) on the Groundwater Sustainable Plan (GSP), the group has 180 days to respond to the State. President Watkins commented the water budget keeps getting better and the deficit keeps getting smaller. Manager Moody expressed caution to the Board because the deficit number could change. President Watkins commented the District will have 20,000 acre-feet of surface water used by customers either this year or next year and noted to keep putting effort into doing projects. Director Atkins inquired on what the original overdraft figure was initially. Manager Moody replied ~80,000 acre-feet, noting you have to compensate for the good and bad years. The next meeting is scheduled for February 3, 2022.

2. Association of California Water Agencies – State Legislative Committee Meeting, 01/07/22 Manager Moody attended the January 7, 2022 Association of California Water Agencies State Legislative Committee (SLC) Meeting. Manager Moody reported there was one bill in the packet, AB-1434 – Urban Water Use Objectives: Indoor Residential Water Use (Friedman). Manager Moody reported the SLC is firmly opposed as this bill attempts to change the statewide standard for indoor residential water use from 55 gallons per person to 42 gallons per person. Manager Moody also reported the ACWA D.C. Conference will be March 1st through March 3rd, will be in-person, and of efforts to push the infrastructure bill so that districts get some funding. Manager Moody also reported on a new farm bill that is in the works. Manager Moody reported that the District's rate-cap legislation was moved into the Assembly. The next meeting is scheduled for January 28, 2022.

F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 01/03/22

Manager Moody provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

There is 130,998 AF in storage at New Hogan Reservoir. Current releases are set at 40 cfs. Current release at Goodwin Dam to Stanislaus River are set at 203 cfs and release to all water users are set at 0 cfs. The water treatment plant is currently processing 19 mgd. The City of Stockton is currently processing 10 mgd.

3. Report on General Manager Activities

a. Stockton East Water District Activities Update

Manager Moody reported on the EvapoTranspiration (ET) Study for the District this Fiscal Year. Manager Moody reported the USBR grant will not be funded until next Fiscal Year however since we have the funds budgeted in this Fiscal Year, the Study will be conducted for just the District and next year we will continue ET efforts for the east-side irrigators.

Re: Satellite ET Project – DCSE Professional Services Agreement

BACKGROUND:

The Stockton East Water District (District) Board of Directors (Board) approved funding within the Fiscal Year 2021-2022 budget to perform an evapotranspiration (ET) study using satellite imagery. The budget included funding to evaluate ET data within the District's service area. On April 13, 2021, the Board adopted Resolution 21-22-01, authorizing District staff to apply for a U.S. Bureau of Reclamation (USBR) WaterSMART Applied Science grant. The intent was to leverage approved District and San Joaquin County funding to perform an ET evaluation of the District, North San Joaquin Water Conservation District, and Central San Joaquin Water Conservation District (Eastside Agencies).

SUMMARY:

On September 2, 2021, the District received notification of pre-award for grant funding. The District and the USBR expected the financial assistance agreement for funding to be executed by November 2021, however staffing challenges at the USBR continues to delay the District's received of an agreement. Due the delays with the USBR agreement and the upcoming end of fiscal year 2021-2022, the District will need to postpone ET evaluation of the Eastside Agencies until fiscal year 2022-2023. Staff proposed to continue engagement with DCSE, the ET evaluation consultant, to perform an ET evaluation of the District's service area for calendar year 2021. The evaluation will support the District's groundwater use information and crosscheck the groundwater use information developed by the Groundwater Sustainability Plan model. DCSE's proposal to evaluate ET within the District's service area is \$49,360.

RECOMMENDATION:

District staff recommend the Board authorize the General Manager to approve a Professional Services Agreement with DSCE not to exceed \$49,360, plus a 5% contingency, for a total of \$51,828 and make all other approvals as necessary. The project is budgeted within the Engineering – Professional Services Planning account and the funding is available.

BACKGROUND

The Stockton East Water District (District) Board of Directors (Board) approved a Professional Services Agreement (PSA) with ECORP Consulting, Inc. (ECORP), at the November 5, 2019, Board meeting for the Bellota Fish Screen and Passage Improvement Project (Project). The PSA included development of the project description, technical studies, AB-52 consultation, preparation of a CEQA documents, and project management. The Board approved budget is \$91,190.

SUMMARY

On December 23, 2021, District staff received notice from ECORP that a pre-historic archaeological site was identified through the cultural resources records search and the site may encroach into the Project area. The physical extents of the pre-historic archaeological site must be determined before the Project team can determine if the site is outside of the Project area, can be avoided through minor design modifications, or must be mitigated through measures incorporated into the CEQA document. The original scope of the ECORP PSA included cultural records searches and on-site pedestrian surveys, but does not include any subsurface exploration for cultural resources

District staff received an additional scope of work and cost on January 10, 2022, to amend the PSA to include the subsurface exploration for cultural resources. The additional cost to perform the subsurface exploration for cultural resources, which is necessary to draft the CEQA document, is \$11,400. Funding for the additional cost is available within the overall Project design budget of \$3,329,422.

RECOMMENDATIONS

District staff recommend the Board authorize the General Manager to approve an amendment to the Professional Services Agreement with ECORP Consulting, Inc., for a revised not to exceed cost of \$102,590, plus a 10% contingency for any additional unforeseen work, for a total of \$112,849, and make all other approvals as necessary. The funding is available within the Fish Screen Improvement Fund.

SCOPE OF WORK

Additional Budget Request for Previously Approved Task

Task 3B: Update Cultural Resources Inventory and Exploratory Testing

Based on the results of the record search from the Central California Information Center (CCIC), a previously recorded pre-contact site, P-39-4531, may be located within the northern bank of Mormon Slough downstream of the existing fish weir within the horizontal and vertical footprint of the proposed project.

In addition to the pedestrian survey originally proposed in Task 3B, ECORP will conduct exploratory subsurface auger testing in the vicinity of where site P-39-4531 was originally recorded to determine the presence or absence of this resource within the vertical footprint of the proposed project area, to assess if the project has the potential to impact the resource.

The augers will be hand driven; approximately 3 inches in diameter and will extend approximately 12 inches (30cm) below the proposed depth of construction at the testing location. No more than 12 auger holes will be excavated. All soils will be passed through a 1/8-inch mesh. All artifacts recovered will be counted, photographed, and accession in the field, and reburied with the backfilling of the augered soils.

Fieldwork shall occur within 2 weeks of Notice to Proceed.

Task 3B Assumptions:

- ECORP will submit USA North ticket prior to exploratory testing to determine the location of underground utilities (if any). We assume the utility representatives will have the necessary access to the facility. This proposal includes the cost of an ECORP archaeologist to map the excavation area and coordinate with the utility companies.
- No more than 12 auger holes will be excavated. If ground conditions preclude auger testing in the locations required to determine presence/absence, or if additional auger testing is deemed necessary to assess whether the project will impact a cultural resource, additional testing can be completed under a contract change order.
- This task includes additional reporting and recording time for the cultural report, but not for the Optional Finding of Effect/Impacts Assessment task.

COST PROPOSAL

The services provided above will be billed on a Time-and-Materials, Not-to-Exceed Basis per task. The estimated costs to complete the work are shown in the following table. A detailed cost estimate showing staff assigned, rates and hours per tasked is also included as Attachment B.

Re: Proposal for the Rebuild of P-27

Background:

The Stockton East Water District (District) contracted with Commercial Pump and Mechanical (CPM) to rebuild P-28 (73388.2 run hours). Upon inspection, the impellers showed signs of cavitation that could lead to premature failure if left unrepaired. P-27 (80543.6 run hours) and P-29 (14422.5 run hours) pumps are made from the same materials, share a common sump and manifold, and are subject to the same hydraulic forces. As a result, staff fully expects P-27 with the highest runtime hours to be in a similar, if not worse, condition as P-28.

Summary:

Based on the findings from the repair of P-28 and the ongoing supply chain disruptions, staff purchased a set of impellers from Pacific Water Resources on 11/9/2021 with an estimated delivery date of 3/9/2022 in anticipation of the rehabilitation of P-27. In addition, the original design of the pump shaft and rigid coupling will not allow for maintenance to repair a leaking or damaged mechanical seal without removing the 600 hp motor. Currently, this would require the District to contract a crane company to remove the motor to make the necessary repairs.

District staff solicited three contractors to provide poropsals to remove, inspect, repair/rebuild, and install P-27. The proposals also include replacement of the existing rigid coupling with a shorter shaft and an Adjustable Vertical Spacer (AVS) coupling, thereby allowing staff to make future repairs or adjustments without removing the motor. The lowest responsible contractor was Mar-Tech, for a total cost of \$50,789.00 (not including impellers) to perform the following work:

- 1. Remove the P-27 pump and motor. In addition, after repairs are completed, reinstall the pump and motor, with an estimated cost of \$9,942.00
- 2. Replace the original rigid pump coupling with an AVS coupling, adjust the shaft to fit the AVS coupling, replace bearings, wear rings, install and dynamically balance impellers. Finally, clean and recondition the pump head, with an estimated cost of \$33,016.00.
- Repair the motor, windings, paint, inspect, install new bearings, surge test, megger stator, and dynamically balance the rotor, with an estimated cost of \$7,831.00.

Recommendation:

Staff recommends the Board authorize the General Manager to execute a contract with Mar-Tech for \$50,789.00, plus a 10% contingency, for a total cost of \$55,867.90 and to make all other necessary approvals. The repairs are included within the \$85,000 budget to rebuild P-27.

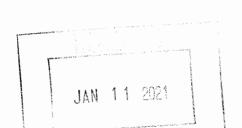
