4. Eastern San Joaquin County Groundwater Banking Authority – Conflict of Interest Code Adoption & Comment Period

Manager Moody provided the Board with information on the Eastern San Joaquin County Groundwater Banking Authority (GBA) Notice of Intention to adopt a Conflict of Interest Code. Manager Moody reported this Conflict of Interest Code specifically effects Directors Panizza & Watkins as they are the primary and alternate District representatives for the GBA. 1. San Joaquin Farm Bureau Federation – Water Committee Meeting, 10/25/16
Manager Moody attended the October 25, 2016 San Joaquin Farm Bureau Federation (SJFB) Water Committee Meeting. Julianne Phillips, San Joaquin Farm Bureau, reported there was no action taken at this meeting. Ms. Phillips reported the SJFB is working towards hosting a community meeting to discuss the Supplemental Environmental Document (SED) in advance of the State Water Resources Control Board (SWRCB) workshops. The Farm Bureau is tentatively hosting the meeting on

December 9, 2016 and Linden/Collegeville Farm Centers will also be invited to attend.

Manager Moody reported Dante Nomellini, Senior Attorney for Central Delta Water Agency will be submitting an Memorandum of Understanding (MOU) to the Sustainable Groundwater Management Act (SGMA) Work Group. The next meeting is scheduled for November 22, 2016.

2. AD HOC Technical Review Committee Meeting for the Sustainable Groundwater Management Act Work Group, 10/26/16

District Engineer Lee attended the October 26, 2016 AD HOC Technical Review Committee Meeting for the Sustainable Groundwater Management Act Work Group. District Engineer Lee reported there were two representatives in attendance from the County of Stanislaus and Merced and provided an update to the group. District Engineer Lee reported primary discussions surrounded the groundwater modeling efforts to include more technical discussion regarding the model domain. Director McGurk inquired on what the model domain is. District Engineer Lee replied the domain is the geographical boundaries of the model. The next meeting is scheduled for November 30, 2016.

F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 10/24/16

President Sanguinetti provided a handout of the Water Supply Report that included storage, release, and production data collected from various sources as of midnight last night.

President Sanguinetti reported there is 76,794 AF in storage at New Hogan Reservoir. Current releases are set at 19 cfs. There is 509,971 AF in storage at New Melones Reservoir. Current release at Goodwin Dam to Stanislaus River are set at 1,090 cfs and release to all water users are set at 1,097 cfs. The water treatment plant is currently processing 16 mgd. The City of Stockton's water treatment plant is currently processing 0 mgd.

President Sanguinetti reported there are no irrigators on the New Hogan system and there are no irrigators pumping on New Melones system.
