# THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF STOCKTON EAST WATER DISTRICT WAS HELD AT THE DISTRICT OFFICE 6767 EAST MAIN STREET, STOCKTON, CA ON TUESDAY, JULY 10, 2018 AT 12:00 NOON

## A. PLEDGE OF ALLEGIANCE AND ROLL CALL

President McGurk called the regular meeting to order at 12:20 p.m., and Manager Moody led the Pledge of Allegiance.

Present at roll call were Directors Atkins, Cortopassi, McGaughey, McGurk, Panizza, Sanguinetti and Watkins. Also present were Manager Moody, Assistant Manager Johnson, Finance Director Vega, District Engineer Lee, Administrative Services Manager Carido, Administrative Clerk Curtis, Legal Counsel Zolezzi and Consultant Barkett.

## C. PUBLIC COMMENT

Mike Callahan, San Joaquin County addressed the Board regarding the County's request for support for the City of Brentwood's Basin Boundary Modification. Mr. Callahan requested the Board revisit the issue. There are currently three basin boundary modifications; one is the City of Lathrop, one is in Sacramento County and the other is the City of Brentwood.

Mr. Callahan reported the Groundwater Sustainability Agencies (GSAs) within the Tracy Subbasin, which includes southwest San Joaquin County, East Contra Costa County and a small portion of Alameda County, are proposing to split the subbasin such that the East Contra Costa County portion would become a separate subbasin for which a separate Groundwater Sustainability Plan (GSP) would be developed.

The proposed subbasin subdivision requires notification of local agencies and public water systems within the subbasin and that written support be obtained from at least 75% of these entities.

Director Sanguinetti inquired what the timeline is to have all letters submitted. Mr. Callahan replied the County would need all letters by the end of July.

President McGurk suggested this be brought back to the Board for consideration and approval.

Richard Wagner addressed the Board and introduced himself as a Director of the Central San Joaquin Water Conservation District (CSJWCD) and landowner within CSJWCD's boundary lines. Mr. Wagner represented himself to the Board as a landowner, not in any official capacity as a CSJWCD Board Member, to foster better communication between the two districts.

Mr. Wagner reported the last time he attended a Regular Board Meeting, there was concern about a weir not being installed. Mr. Wagner spoke with CSJWCD's Chairman, Grant Thompson and the weir has since been installed. Director Sanguinetti thanked Mr. Wagner for talking with Mr. Thompson and getting the weir installed.

Mr. Wagner reported CSJWCD has an upcoming Board Meeting and wanted to inquire if SEWD's Board has any items they would like addressed at that time. President McGurk replied after the Eastern Water Alliance (EWA) meeting on Monday, July 9<sup>th</sup> Mr. Thompson approached President McGurk and advised he would like each district's Ad Hoc Committee to meet together and discuss the potential merger of the two districts. Mr. Thompson would like to move as quickly as possible and would like to have something in place prior to next irrigation season.

President McGurk reported the District's Ad Hoc Committee is comprised of himself and Director Panizza. President McGurk reported staff will put together a framework prior to the meeting so he and Director Panizza are prepared for discussion topics.

Mr. Wagner inquired if the District has received all financial information. Manager Moody replied the only missing information is the amortization schedule from the Bank of Stockton.

#### E. COMMITTEE REPORTS

1. San Joaquin County & Delta Water Quality Coalition Meeting, 07/09/18

Director Atkins attended the July 9, 2018 San Joaquin County & Delta Water Quality Coalition Meeting. Director Atkins reported there was discussion on the Financial Report. The Coalition is over on their Stationary & Printing budget due to the printing of Sediment Erosion Plans that were printed in color, which drove the cost up. Director Atkins reported there was discussion on the Program Manager's Report. Five new chemicals on the market were found in water. Director Atkins reported there are only a handful of landowners left who need to submit their Sediment Erosion Plans. The next meeting is scheduled for August 13, 2018.

## 2. Eastern Water Alliance Meeting, 07/09/18

Directors McGurk and Sanguinetti and Manager Moody and staff attended the July 9, 2018 Eastern Water Alliance (EWA) Meeting. President McGurk reported the group discussed the need to establish a five member Monitoring Committee established as part of the export permit for the Demonstration Recharge Extraction and Aquifer Management (DREAM) Project. One of the members on the Monitoring Committee must represent the EWA.

Director Sanguinetti reported North San Joaquin Water Conservation District (NSJWCD) has been designated by the EWA as the operator of the DREAM Project, so representatives for the Monitoring Committee were selected from another EWA member agency.

Manager Moody reported Grant Thompson, Central San Joaquin Water Conservation District nominated Manager Moody as the Primary for the Committee. Manager Moody requested District Engineer Lee be selected as the primary and Manager Moody as the alternate.

President McGurk reported the Committee will be consist of: the San Joaquin County Director of Public Works or designee; the San Joaquin County Director of Environmental Health or designee; a representative from the EWA; a representative of the local agency that provides water service in the project area and a representative of landowners within two miles of the project area.

#### F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 07/09/18

Manager Moody provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

There is 194,840 AF in storage at New Hogan Reservoir. Current releases are set at 188 cfs. There is 1,895,917 AF in storage at New Melones Reservoir. Current release at Goodwin Dam to Stanislaus River are set at 303 cfs and release to all water users are set at 1,625 cfs. There are currently 14 irrigators on New Hogan, 2 irrigators on New Melones and 2 Out-of-District irrigators. The water treatment plant is currently processing 36 mgd. The City of Stockton is currently processing 26 mgd.

Assistant Manager Johnson reported he was able to talk with General Managers from other districts that he has created relationships with over the years and they were able to discuss challenges that each district faces. Assistant Manager Johnson reported Chip Eichelberger who is a motivational speaker gave a good presentation on having more energy and getting "Switched On". Assistant Manager Johnson reported he attended a session on "Strategies to Manage Increasing Pension Costs" and a session presented by Delta Diablo Water District and Orange County Sanitation District on "The Time to Tell Your Special District Success Story to Customers is NOW!" Assistant Manager Johnson reported he also attended an interesting presentation on "Choose Your Own Employee Discipline Adventure".

Manager Moody provided the Board with a handout inviting them to the District's 70<sup>th</sup> Birthday celebration on August 3<sup>rd</sup>. This event will be held in the freshly renovated Operations Building.
